

obvious and is greatly appreciated.



NPVA Donates \$6350 to Charities

The NPVA membership approved donations to the non-profit organizations listed below. Congratulations to all the recipients and a sincere thank you for all you do to support veterans.



Hospital for the Chronically III (DHCI), located in Smyrna, Delaware, Dis a state-operated nursing home providing care for residents who cannot be served in community settings or private nursing facilities. They offer a full range of medical and support services, including skilled nursing care, rehabilitation therapy, social work, and dietary services.



The Fisher House for Families of the Fallen at Dover Air Force Base, Delaware, is a unique facility among the Fisher House Foundation's other locations. It is the only one of its kind, designed for families of the fallen and managed exclusively by uniformed personnel. It is designed to provide short-term, on-base lodging to families who travel

to Dover AFB to witness the dignified transfer of their loved one.



The MOAA ROTC Scholarship Fund provides financial assistance to ROTC cadets pursuing careers in the military. The scholarships help to OAF offset the cost of tuition and fees, making it easier for students to attend college and fulfill their military service commitment.



The DAV (Disabled American Veterans) Chapter 1 advocates for the needs of veterans and their families in Delaware. They offer a variety of services, including counseling, employment assistance, and access to benefits.



The Quilters of Noble's Pond honor our community's veterans yearlong as they stitch handmade quilts that they distribute to selected veterans.

FIRST STATE The 1st State Military Academy is a public charter high school in Del-MILITARY At aware that offers a rigorous academic curriculum combined with military training. The academy prepares students for college and future careers, instilling values of discipline, leadership, and service.



Home of the Brave provides transitional housing and support services for veterans and their families. They help veterans reintegrate into society after their service, assisting with housing, employment, and mental health care.



The Gary Sinise Foundation serves injured veterans, first responders, and their families. They offer a variety of programs, including building specially adapted smart homes, providing financial assistance, and organizing recreational outings.



The USO Dover provides a welcoming environment and support services for active-duty military personnel and their families. They offer a variety of programs and activities, including relaxation rooms, game areas, and free meals.



Honor Flight provides veterans with an opportunity to visit Washington, D.C., and see the memorials dedicated to their service. The flights are free of charge and allow veterans to reflect on their sacrifices and connect with fellow veterans.



AFJ ROTC DE 081 is the Air Force Junior ROTC unit at Dover High School. The program teaches students about leadership, citizenship, and aerospace science.



The AMC Museum Foundation supports the Air Mobility Command Museum in Dover, Delaware. The museum houses exhibits on the history of military airlift and air refueling, and it honors the contributions of air mobility personnel.



The Delaware Submarine Association serves as a support network for active-duty and retired submariners and their families. They offer a variety of programs and events, including social gatherings, educational opportunities, and support services.

Past President Joyce Jamison Comments and Reviews 2023

As I reflect on my tenure as the President of NPVA, I am filled with gratitude for the opportunity to have served you. This year, which seemed to fly by, was marked by significant achievements for our Association.

Upon assuming office, I pledged to build upon the success of the previous Board. To achieve this, I outlined a set of goals for the Association, encompassing short-term, midterm, and new initiatives. These goals were designed to aligned with the board's objectives and address priority concerns, integrating input from both our members and the Board.

Short term Goals (within six months) were to integrate new faces leading committees, NPVA Newsletter, and a new veteran welcome letter.

- Committee integration and Leadership: We successfully integrated new leaders into key committees. Notably, the Flag Placement Captains, Howard Goodhand and Bobby Turner, led a team of 21 volunteers. They revolutionized our process, reducing time spent on the street by 125%.
- NPVA Newsletter and Veteran Welcome Letter: The launch of the 'Veteran Voice' newsletter by Bill Newmiller, Kim Callene, and Trish White was a milestone. Not only did it provide critical information to the community, but it also evolved into the informative website "Noble's Pond Veterans' Association" (www.npvets.org). Additionally, our welcome letter initiative, successfully attracted new members to our Association.

Mid-Term Goals (six months – 11 months) were to review our Bylaws, campaign to increase active membership, and provide an environment for every member's voice to be heard.

Bylaws Review: The review committee consisted of Board members, our immediate
past-president (Walt Waite), one former president (Bob Sly), and two new members
(Tom Mehl and Howard Goodhand). The review process resulted in an overhauled of

the original version which was adopted by our members in November 2023, delineating our purpose and operational guidelines.

- **Membership Campaign**: Although the Campaign initiative did not materialize, we saw a 7% increase in active membership.
- **Member Voices**: Under my leadership, we ensured that every member's voice was heard and respected, adhering to Robert's Rules of Order and fostering a participatory environment. This was a huge hurdle in overcoming past practices. Overwhelming, numbers of members voiced their approval of this change.
- 2023 New Initiatives: The focus was on transitioning to a member-driven Association. We saw remarkable participation in initiatives such as the NPVA Veteran's Roster (Howard Goodhand), Sunshine Coordinators, Polo Shirts Committee, and the Flag Day Ceremony (Dee Sullivan and Patty Wysong). These efforts demonstrated our members' commitment and leadership.
- Community Engagement and Field Trips: Our involvement in community events like
 the July 2nd Sunday Grilling (Moe Moy) and the Honor Flight experience reflected
 our dedication to both community and veteran causes. The fundraising initiatives, led
 by Bob Sly and Walt Waite, were particularly successful, raising a record amount for
 the Association.
- Traditional Community Events: We maintained our presence in traditional events like the Memorial Day Ceremony, Veteran's Day Ceremony (Dee Sullivan), the July 4th Parade, and the Christmas Parade. These events were executed with professionalism and enthusiasm by both veteran and non-veteran volunteers.

Since its foundation in 2015, the Nobles Pond Veterans Association has emerged as a cornerstone of support and camaraderie within its community, making significant strides in honoring and assisting veterans through a wide array of endeavors. Powered by the relentless dedication of its volunteers and bolstered by the generous contributions from the Nobles Pond community, the association has successfully marshaled approximately \$24,000 in donations.



These funds have been thoughtfully allocated to a broad spectrum of beneficiaries, including but not limited to USO Delaware, the Milford Veterans Home, the MARSOC Foundation, the Delaware Hospital for the chronically ill, and the esteemed Gary Sinise Foundation. This financial aid represents just a fraction of the association's comprehensive efforts to uplift and honor those who have served.

Beyond its financial contributions, the Nobles Pond Veterans Association has profoundly impacted the veteran community through a variety of commemorative and supportive activities. The establishment of a flagpole and an honor wall dedicated to deceased veterans stands as a permanent testament to their sacrifice, while the organization of patriotic parades and ceremonies on Memorial Day, Veterans Day, the Fourth of July, and Christmas fosters a sense of unity and remembrance within the community. The association also organizes

engaging social events, such as pancake breakfasts, chicken parmesan dinners, and a pig roast, further knitting the community together in support of veterans.

The Nobles Pond Veterans Association's commitment to honoring veterans extends to thoughtful gestures like placing American flags at each veteran's home on significant holidays, arranging flags along Guard House Lane, and acknowledging each veteran's service with a personalized "Veteran" sign at their residence. The creation of a service branch flag display stand and the provision of a color guard for events at locations like the Wild Meadows and Milford Veterans Home exemplify the association's dedication to public acknowledgment of veterans' service.

Furthermore, the association has undertaken larger projects, such as the procurement of a larger flagpole for the American flag in the ballroom, ensuring the flags are replaced as necessary to maintain their dignity. Organizing bus trips to Arlington National Cemetery and Quantico offers veterans and community members poignant experiences of reflection and connection. The association's efforts to facilitate Nobles Pond veterans' participation in the Honor Flight program, as well as arranging informational sessions with the VA and DAV about veterans' claim statuses, demonstrate a deep commitment to the well-being and recognition of veterans.

By successfully incorporating as a 501(c)(4) nonprofit and navigating the administrative requirements to bring bingo and other community events to life, the Nobles Pond Veterans Association has solidified its role as a vital organ of community engagement and support for veterans. Through its comprehensive range of activities, financial support, and the symbolic gestures of honor and remembrance, the association embodies the profound respect and gratitude owed to those who have served, making it an invaluable asset to both the Nobles Pond community and the wider network of veteran support.

Dover AFB Pharmacy can use a few Good People

NP Vet John Hansen is a longtime volunteer at the Dover AFB Pharmacy. According to John, "a typical commitment is 4-5 hours a week at a time convenient to the volunteer." Volunteers need not have any specialized medical knowledge. John describes the volunteer work as "dispensing medication, manning the pick-up windows, and other tasks that free-up the military and staff to concentrate on the more technical aspects of the pharmacy system." A posting on the Dover AFB website praises volunteers like John who "take up to 25 percent of the workload, enhancing the readiness of the active-duty personnel."
